[15] Description of Product

The Camera Module, CAM-SW-001831, is a flameproof enclosure containing three cameras. Light Module, LED-SW-002238, is a flameproof enclosure containing LED lights. The Camera Module and Light Module are factory wired with a cable leaving the enclosure through a potted cable gland.

Performance Testing

The optical radiation output of the product with respect to explosion protection, according to Annex II clause 1.3.1 of the Directive 2014/34/EU is not covered in this certificate.

Temperature range

The ambient temperature range is $-20\text{ °C} \leq T_a \leq +60\text{ °C}$.

Routine tests

Batch overpressure tests in accordance with ISO 2859-1[5] and Clause 16.6 EN 60079-1:2014 shall be conducted on all CAM-SW-001831 and LED-SW-002238 utilizing BK7 glass manufactured by CRYSTRAN at a pressure of 8.27 bar (120 PSI). If there are any non-compliant results, 100% routine testing of the remaining samples in the batch shall be performed at 8.27 bar (120 PSI).
