[15] Description of Product

The Drive Module, DRV-SW-001925, is a flameproof enclosure with two motors located completely within the enclosure. The Drive Module contains two separate drive connections through the wall of the flameproof housing for mechanical connections to the internal motors. The Drive Module is rated for continuous duty for up to a 5 Amp total load (2.5 Amp for each end). The Drive Module is rated for a duty cycle of up to 10 Amp total (5 Amp each end) for 90 minutes with power on and at least 3 hours with power off.

Temperature range

The ambient temperature range is $-40\text{ °C} \leq T_a \leq +55\text{ °C}$ or $-40\text{ °C} \leq T_a \leq +60\text{ °C}$ depending on the cable that is installed and provided with the Drive Module.

Electrical data

36V DC, 5 Amp continuous or 10 Amp Duty

Routine tests

Routine tests according to EN 60079-1 cl. 16 are not required, as the enclosures have been successfully tested at four times the reference pressure.
